4-H Poetry Contest Rules

- Poems must be the original work of the 4-H member. (Plagiarized poems will be disqualified.)
- Junior 4-H members are between the ages of 9-13. Senior 4-H members are between the ages of 14-18. Age is determined by the youth's age on December 31 (of current year).
- Poems can be written on any age-appropriate subject. Poems must be family-friendly.
- Poem must have a title.
- Poem should be typed or neatly written on regular-size, lined paper. (If time permits, typed poems are preferred.)
- ♦ Poem should be between 3-25 lines. Haikus are permitted.
- The poem should contain the youth's name, age, school, and grade at the end of the poem.
- County champions will be selected by the judge. There will be <u>two</u> junior champions chosen, and <u>two</u> senior champions chosen. These champion poems advance to the State 4-H Written Communication Contest.
- Poems submitted to the county contest should have the statement of authenticity attached.

4-H Poetry Contest Deadline is Friday, November 22, 2024.

Poems need to be delivered or e-mailed to 4-H agent by 3:30pm. There is a drop box by the Extension Office kitchen door for you convenience when the office is closed.


