The 4-H Camp sign-up process will be two-phased this year. Sign up day will be Monday, March 11, 2024 and begin at 8:00am via Sign-up Genius. The links for boys and girls camp spots will be separate links and posted on the Russell County Extension Service website: <https://russell.ca.uky.edu/> and on the Russell Co. 4-H (KY) Facebook page. Camp spots are limited and will be filled on first-come basis.

Campers must be registered individually on the site and they must be registered in the correct gender link or they will be dropped from the sign-up list. After 3/11/24, the links will be removed from this website and all remaining camp spots will be filled in-person at the Russell Co. Extension Office.

If you registered through Sign-up Genius on March 11, 2024, you will need to bring the attached, completed camp application to Russell County Extension Service (across from Mighty Dollar Store) and the required deposit by Friday, March 15, 2024 or your child will be dropped from the original sign-ups.

After March 11, 2024

If any bed space is available after sign-up day, please bring the completed camper application to the Russell County Extension Office. If spots are available, camp applications will be accepted through Friday, March 29, 2024.

Once camp applications close at the end of March, additional UK 4-H camp paperwork will be mailed to families to complete with a letter regarding the date of final payment.

Application process

1. Fill out and sign this form (both sides).
2. Attach current photo of 4-H camper.
3. Bring an \$70 deposit (or full payment of \$210) payable to Russell Co. 4-H Council. [\$10 is non-refundable.]
4. Camp beds are filled on a first-come basis. When bed spaces are full, youth will be placed on a waiting list.
5. **Read attached letter for "sign up day" procedures using Sign Up Genius and register per the instructions. When you do the online sign-up, then bring this paperwork and payment to the Russell Co. Extension Office by Friday, March 15, 2024 or camp spot will be forfeited to a person on the waiting list.**
6. After the "sign up day/March 11," any remaining spots will be filled by bringing this application to the Russell Co Extension Office (in person). Office hours are M-F from 7:30am-noon and 1:00-4:00pm.
7. Final registration date is Friday, March 29, 2024.
